- B. **Second Reading/AN ORDINANCE AMENDING ORDINANCE NUMBER 1242 (THE ZONING ORDINANCE) OF THE CITY OF LA JUNTA AS CONCERNS AN APPLICATION FOR ANNEXATION BY JEFF PAOLUCCI.** The ordinance was read by title only, there being copies available to those in attendance.

City Manager Rick Klein introduced our new Economic Development/Urban Renewal Director, Cynthia Nieb.

NEW BUSINESS

- A. **Appointment to fill Ward 2 Council Vacancy.** Mayor Pruyn thanked all those who put in a letter wanting to be on City Council. We really appreciate that so many people want to but unfortunately we only have one seat to fill. I really hope that even if you don't make it on the Board this time; that you stay involved with the community. These seats come up every two years so this won't be your last chance.

With that, here is how we will proceed with the vote. I will read each of the candidate names and after each name, those on council wanting that candidate to fill the ward two vacancy will vote yes, each council person shall only vote once. The candidate who receives the most votes will fill the vacancy. If there is a tie for most votes, the council will re-vote on just those candidates and the candidate with the most votes will fill the vacancy. If the candidates continue to tie in votes, we will have to move to a Special Election. Any candidate that receives four or more votes will automatically fill the vacancy.

I will begin reading the names beginning with ladies first. Everyone please make sure that your switches are on neutral. Our first candidate on our list is:

Shannon Lovato – Those voting YES are: Mestas, Goodwin, McIntyre, Pruyn

Shannon Lovato received the majority of the votes so she will fill the Ward 2 Council seat and there will be no need to continue on with the names.

- B. Application for Renewal of a Tavern Liquor License by Ronald Hall, d/b/a The Railyard, 114 Colorado Avenue.** The application is in order and has been reviewed by City supervisors for compliance with City and State codes. The premise is under an action plan through the Fire Department. Appropriate fees have been tendered and the City Clerk recommends approval.

D. City Manager's Comments

1. Spent two weeks in La Junta on a stay-cation. I love this community. Everybody is so kind. We had good conversations. It reminded me why I live in this community.
2. Thank you to all the candidates. It's tough to put yourself out there. Everybody wants to make a difference in the community. All the candidates had their hearts in the right place. This year, let's make a big difference, let's get this community going.
3. Looking forward to 2018.

Council Member Vela: That place over there at 10th and Barnes where the disc golf course is, what's the status on it now? Is it running, is it operable?

City Manager Klein: Yes and I would have never thought we had that many people that played disc golf. Even when it was real cold I saw a guy bundled up like a snowman out there playing. The course is open. Southeast Health Group put it in using a grant.

Mayor Pruyn: I have two requests. The first one is, next year at Christmas; let's do something with the train. The fencing around it or whatever, let's decorate it. There's somewhere southwest where they decorate their whole train. Second, refinishing the tennis courts at the park, is there any chance something like that is going to happen?

City Manager Klein: What I was going to do was get the bathrooms going first and then move over and work on the tennis courts.

Council Member McIntyre: What about the option of doing something different. People might want a different outdoor activity since we have the other tennis courts on San Juan.

City Manager Klein: Whenever we would change the use, because it is a historic park, we would have to get with the Historic Trust to see if that would be acceptable. But that's just a process and we should never be afraid of the process. We went through that same process with the trees.

Council Member Vela: She's in the back of the room, can't you ask her now?

City Manager Klein: She doesn't work there anymore. But, did I say anything out of sorts?

Economic Director Nieb: No you didn't and he's right, you shouldn't be afraid of the process. You ask the question, and they will do the best that they can to make it a yes.

Council Member McIntyre: Maybe we could do a splash pad and that might draw people into town more.

E. City Attorney's Comments

City Attorney was not in attendance.

F. Governing Body's Comments

1. Council Member Goodwin: I'd like to give credit where credit is due with our city employees. Aimee Hill sent out a very professional letter a few days ago to all of us on the boards that she's involved in and got us up to date for 2018. It's very much appreciated. Thank you.

2. Council Member Vela: I read a letter in the paper about the hospital and how they're operating. I wondered if we should bring to light what council will do for the request for funding to remove the electric cost adjustment. Did we get a copy of Dean's letter or did he ever send one?

Mayor Pruyn: I think there's a copy out there so we can get a copy to you if you want it.

Council Member Vela: Should we tell people what's going on because this is the second article on the hospital board. People now have to go to St. Mary Corwin for cancer work and now it's even bothersome that Loma Vista closed. St. Mary Corwin is saying that there's more money in cancer than there is babies because they're not delivering babies anymore, Parkview is the only one. We should be a little concerned about that. Also, do we have any kind of action with regards to backing up Loma Vista? Is somebody trying to do something with them to try to help them out? I wish we had heard of that earlier because that's a sore spot in the community.

Mayor Pruyn: I know that Valley Wide has incorporated some of their doctors. They have actually been looking at the possibility of expanding. I'm hoping the medical community is going to do something.

3. Council Member Mestas: Rick, can you bring us up to par on the nursing home?

City Manager Klein: Actually, my parts done. Once they get into building it, I told them to reach out to me because I've done a lot of projects. I would help them through some of those processes.

Council Member Mestas: Where is it going to be built?

City Manager Klein: They have not made that decision. They do have options and there have been community people that have come forward and said that they would sell their property.

4. Cheryl Lindner, 16 E. 22nd St.: A follow up to Ed's comment about if you could bring light to what City Council has decided with regards to the hospital's request to waive the e-cost adjustment for their utilities.

Mayor Pruyn: Without going into a lot of detail, the letter that Mr. Malouff sent back to Mr. Nichols, basically said that that wasn't a decision to be made by City Council. It has to start at the Utility Board but we also said that we are not dealing with decisions that have to do with the new nursing home because that goes to the hospital district. So, basically we said that we're not going to be doing anything about that right now. We, as a Council, are not favorable in moving forward with that.

5. Mayor Pruyn: Our next meeting will be on a Tuesday again because Monday is Martin Luther King Day, so that'll be January 16th. At that meeting, we will be swearing in our new Ward 2 council person. Once she is sworn in, we will set dates. I would still like to get the work session in by the end of January or first part of February at the latest. We should also start planning on the Meet & Greet that we will have with it. I would encourage everyone on council, if they have a subject they're interested in having at that work session, make sure that Melanie knows or myself so we can make sure it gets on the agenda.
